#### **Closed Circuit Television (CCTV)Policy**

Scaynes Hill Millennium Village Centre (SHMVC)has installed CCTV cameras to cover the front and rear entrances to the hall.

#### **Purpose and Objective**

- 1. To monitor activity around the hall and support the police in identifying antisocial or illegal behaviour.
- 2. To deter antisocial and illegal behaviour.

This CCTV policy reflects the code of practice of The Data Protection Act 2018 and The General Data Protection Regulation 2018. SHVC complies with the Government's Code of Practice (https://www.gov.uk/data-protection-your-business/using-cctv) to ensure that it is used responsibly. An annual registration fee is paid to https://ico.org.uk/for-organisations.

#### **Signage**

CCTV signs are clearly and prominently displayed at the Main Entrance Door and at the front of the Main Hall. There will be a notice with details of the "Data Controller" who has responsibility for the system on the notice board.



Siting the Cameras and Coverage

Cameras have been sited carefully so that they only show images relevant to the purposes

for which they are installed (described in "Purpose and objective" above) and care has been

taken to ensure that reasonable privacy expectations are not violated.

Regular and ad hoc hirers will be informed of the policy.
